



## Democratic Delegate Raises Concerns Over Biden Campaign

#### **BY JAN FRAZIER**

A Democratic delegate from California has raised concerns about a recent interaction with the Biden re-election campaign, which he interpreted as an attempt to stifle internal discussion among party delegates regarding President Joe Biden's candidacy. The delegate, who requested anonymity to speak freely, told CNN on Wednesday that he received a call from a member of "Biden-Harris delegate operations" team that left him feeling uneasy.

that the campaign official's first question was whether he understood his obligations as a "Biden-Harris pledged delegate." The delegate, who has participated in previous Democratic conventions, confirmed that he was aware of his responsibilities. However, the follow-up questions—asking if he had any other inquiries and confirming his phone number—struck him as odd.

According to the California delegate, another colleague from the state had a similar



experience with the same campaign staffer. Both found the outreach unsettling, especially since they had expressed concerns about Biden's viability as the party's 2024 candidate in conversations with fellow delegates.

When CNN reached out to the Biden campaign for comment, a spokesperson from the Democratic National Convention redirected inquiries,

explaining that the campaign had been regularly engaging

with state parties and delegations since 2023, but did not address the specifics of the calls.

This incident has added to the ongoing debate within the Democratic Party over Biden's candidacy and how the campaign manages internal party dynamics.

# Hurricane Beryl: A Record-Setting Category 5 Storm Devastates the Caribbean



Hurricane Beryl has intensified into a Category 5 storm—the earliest on record—causing destruction across the Caribbean after making landfall in the Windward Islands. At least one fatality has been confirmed as the hurricane swept through the region.

According to the National Hurricane Center (NHC), Beryl's maximum sustained winds reached near 160 mph, with gusts even higher. This marks only the second time an Atlantic hurricane has achieved Category 5 status in July, following Hurricane Emily, which reached that intensity on July 17, 2005.

The NHC forecasts fluctuations in Beryl's strength over the next day, but the storm is expected to maintain major hurricane status as it moves toward the central Caribbean and approaches Jamaica on Wednesday.

Beryl made landfall on Grenada's Carriacou Island shortly after 11:00 a.m. EDT, with maximum winds recorded at 150 mph. It is the most powerful hurricane documented to traverse the Grenadines since records began in 1851.



Prime Minister Dickon Mitchell of Grenada reported widespread destruction in Carriacou and Petite Martinique during a news briefing. "In half an hour, Carriacou was flattened," he said, noting no immediate reports of fatalities or injuries in Grenada, though he cautioned that the situation could change.

In St. Vincent and the Grenadines, at least one death has been reported, with Prime Gonsalves Minister Ralph indicating extensive damage to hundreds of homes and buildings. Many areas are without currently water or electricity, exacerbating the situation. Gonsalves described the aftermath of Beryl as leaving "immense destruction, pain,

[and] suffering" across the nation. Union Island, situated just north of Grenada, suffered particularly severe damage, with reports indicating that up to 90% of its homes have been destroyed.

In Grenada, approximately 95% of the island has lost power due to the hurricane. Neila K. Ettienne, press secretary for the Prime Minister's office. confirmed that telecommunications are down, and many residents have lost internet access. All schools and businesses are closed, including the airport, with only hospitals and the national police force remaining operational. airport recorded a sustained wind speed of 92 mph.

#### **Escalation in Khan Younis: Mass Evacuation Ordered Amid Renewed Military Actions By Eric Gahagan**



In a significant escalation of Younis, which military operations, the Israeli armv has issued a mass evacuation order for residents of Younis, signaling impending ground assault on Gaza's second-largest city. This development highlights Israel's ongoing efforts to dismantle Hamas, particularly as the region continues to grapple with the aftermath of earlier offensives.

evacuation The notice specifically affects the eastern half of Khan Younis and a large section of the southeastern Gaza Strip. Earlier in the day, the army reported that rockets had been launched from Khan Younis, raising concerns about renewed conflict in the area. The evacuation follows a history of destruction in Khan

had already suffered extensive damage during previous assaults earlier this year. Despite this, many Palestinians had returned after fleeing earlier violence in Rafah, complicating humanitarian situation

The evacuation coincides with the recent release Mohammed Abu Selmia, the former director of the Al-Shifa Hospital, who had been detained by Israeli authorities for seven months without charge. Israel accused the hospital of being used as a Hamas command center, a claim that Abu Selmia and other health officials have vehemently denied. The circumstances his surrounding detention. including allegations of torture,

have raised serious questions about Israel's handling of the situation and its regarding the hospital.

The decision to release Abu Selmia has sparked a political backlash in Israel, with Prime Minister Benjamin Netanyahu's office describing it as a "grave mistake." Political leaders across the spectrum have expressed outrage, asserting that Abu Selmia had ties to Hamas. Such claims, however, often fail to account for the Israeli security services' protocols regarding prisoner releases

Additionally, the area encompasses the Kerem Shalom crossing, a key humanitarian aid route.

With a staggering majority of Gaza's 2.3 million residents already displaced, the ongoing conflict exacerbates the humanitarian crisis, leading to severe shortages of food, water, and medical supplies. The U.N. Secretary-General, Antonio

Guterres, condemned the evacuation order, stating, "No place is safe in Gaza for Palestinian civilians," and calling for an immediate cease-fire to halt the cycle of violence

As the situation unfolds, the international community watches concerned closely, about the deteriorating humanitarian conditions and ongoing conflict's implications for regional stability.

## Bolivia Summons Argentine Ambassador Over Coup Comments Amid Rising Tensions By Jan Frazier

The Bolivian government has summoned the Argentine ambassador in response to statements from President Javier Milei's office, which labeled claims of an attempted coup in La Paz as "fraudulent."

Interim Foreign Minister Maria Nela Prada addressed the media, Bolivia stating that rejects" "energetically the comments made bv Milei's administration. This diplomatic tension follows an incident on June 26, when General Juan Jose Zuniga led military units to assemble in La Paz's main which houses square, the presidential palace Congress. In a dramatic display,

an armored vehicle breached the palace doors, allowing soldiers to storm the building.

Zuniga later claimed he was acting under orders from President Luis Arce, who has denied any involvement or prior knowledge of the military operation. In a statement released on Sunday, Milei's office dismissed the Bolivian government's assertions as "not very credible" and firmly rejected the accusation of a coup, calling it "fraudulent."

The Milei administration, known for its far-right libertarian stance, further warned that Bolivia's socialist government poses a danger to the country, referencing the imprisonment of former President Jeanine Anez and Santa Cruz Governor Luis Fernando Camacho.

In response to these claims, criticized Argentina's "skewed remarks as uninformed," describing them as an "excessive and unacceptable form of denial." The situation escalated. drawing condemnation from President Evo Morales. political rival of Arce. On social media platform X, stated.

"No matter our differences with the current government, we do not lose sight of the fact that Milei is an enemy of the people."

As diplomatic tensions continue to rise, the implications of this exchange between Bolivia and Argentina remain to be seen, highlighting the fragility of regional relations amid political strife



## Australia Doubles International Student Visa Fees Amid Migration Pressures By Jan Frazier

In a significant policy shift, Australia has more than doubled its visa fee for international students, a move designed to manage soaring migration rates that have strained the housing market. Effective July 1, the fee for an international student visa has increased from A\$710 (\$471) A\$1,600 (\$1,068).to Additionally, holders of visitor and temporary graduate visas prohibited now from are applying for student visas while in Australia.

Home Affairs Minister Clare O'Neil emphasized that these changes aim to enhance the integrity of Australia's international education system and create a more balanced migration framework. "The changes coming into force today will help restore integrity to our international education system and create a migration system.

Recent data revealed a staggering 60% increase in net immigration, reaching a record 548,800 people in the year ending September 30, 2023. The significant rise in visa fees now positions Australia as a more expensive option international students compared to countries like the U.S. and Canada, where student visa fees are approximately \$185 C\$150 and (\$110),respectively.

To address concerns over visa compliance, the government is also closing loopholes that previously allowed foreign students to extend their stays in Australia indefinitely. In 2022–23, the number of students on a second or subsequent visa surged by over 30%, exceeding 150,000.

These measures follow a series of regulatory changes

introduced since late last year, in response to a spike in migration after the lifting of COVID-19 restrictions in 2022. Earlier this year, English language requirements were tightened. and the savings threshold for international students seeking a visa was raised to A\$29,710 (\$19,823) from A\$24,505.

The CEO of Universities Australia, Luke Sheehy, expressed concerns over the government's ongoing pressure on the sector. "This is not good for our economy or our universities, both of which rely heavily on international student fees," he remarked in an email response.

As Australia navigates these changes, the long-term implications for its international education sector and overall economy remain to be seen.



## South Africa's New Power-Sharing Cabinet: A Historic Shift ByJan Frazier

In a groundbreaking political development, South African President Cyril Ramaphosa has appointed a coalition Cabinet comprising seven different parties. This unprecedented power-sharing arrangement comes in the wake of the African National Congress (ANC) losing its parliamentary majority in a historic election held in late May.

#### A New Political Landscape

Ramaphosa's announcement on Sunday night marks a significant departure from the ANC's 30year dominance in South African politics, a tenure that began after the end of apartheid in 1994. The new multiparty Cabinet is the result of a month of intense negotiations, primarily between the ANC and the Democratic Alliance (DA), the former leading opposition party now willing to share power.

The coalition consists of 11 parties, with seven securing positions, but the Cabinet primary alliance remains between the ANC and the DA. This collaboration is notable, given their longstanding ideological differences and decades of rivalry.

## **Key Cabinet Positions Retained** by the ANC

Despite the new multiparty Cabinet, the ANC retains control over vital ministries. Ramaphosa reappointed Paul Mashatile as Deputy President and kept ANC members in charge of critical portfolios, including finance, trade and industry, foreign affairs, defense, and justice. The ANC, which garnered 40% of the votes in the recent election, holds 20 of the 32 Cabinet minister positions.

The ANC's continued leadership in the foreign ministry suggests a persistent pro-Palestinian stance, especially as South Africa pursues a sensitive case against Israel at the United Nations. The nation is also set to assume the presidency of the Group of 20 (G20) in the coming year, amplifying its influence in international affairs.

#### Concessions Made to the DA

significant In а move. allocated Ramaphosa ministerial positions to the DA, appointing its leader, Steenhuisen, as Minister Agriculture. Although the DA sought the trade and industry portfolio, it received deputy minister roles instead, which will serve as critical tests for their collaboration with the ANC.

The ANC and DA's ideological divides are evident, particularly regarding economic policies. The ANC defends its Black Economic Empowerment initiative aimed at correcting historical injustices, while the DA advocates for a race-neutral policy framework.

#### **Navigating Racial Dynamics**

The coalition faces broader challenges linked to South Africa's complex racial dynamics. The ANC, a symbol of liberation from white minority rule, now partners with the DA. which is often perceived as representing the interests of the country's small white minority, comprising just 7% of the 62 million population. While the DA maintains support among many Black South Africans, the



historical context of apartheid complicates perceptions.

Ramaphosa's Cabinet also includes the leader of the Freedom Front Plus party, which has roots in right-wing politics. Their inclusion raises further questions about whether South Africa can overcome its racial divides within this unprecedented coalition.

#### **Steep Challenges Ahead**

Despite pledging collaborate, both Ramaphosa and Steenhuisen face significant obstacles. While the supported Ramaphosa's bid for a second term in Parliament, the coalition must navigate South Africa's pressing socioeconomic issues. With soaring official inequality and an unemployment rate of 32%, reaching 45% among youth, the coalition's effectiveness will be tested.

Additionally, South Africa grapples with high violent crime rates and deteriorating public services, exemplified by a series of severe electricity blackouts throughout 2023. These systemic challenges contributed to the ANC's decline in the recent election, compelling a reevaluation of governance in the country.

# Australia Sets Six-Month Deadline for Internet Industry to Protect Children from Inappropriate Content By Randy Whitehead



Australia has issued a sixmonth ultimatum to the internet industry, requiring the development of an enforceable code to prevent children from accessing pornography and other harmful materials online. If the industry fails to meet this deadline, a regulatory code will be imposed.

The Safety Commissioner has formally requested that industry stakeholders submit a plan by October 3 detailing how they will shield minors from high-impact content, including themes related to suicide and eating disorders. This initiative aims to establish standards across various platforms, such as app

websites, search engines, social media networks, chat services, and multiplayer gaming platforms.

"Parents and caregivers are understandably concerned about children's exposure to violent and extreme pornography," stated eSafety Commissioner Julie Inman "However, Grant. the responsibility cannot rest solely on them; the industry must implement effective barriers as well."

This initiative marks the beginning of a second phase in the regulatory oversight of industry codes, which have

previously addressed issues such as the dissemination of terrorism-related content and child sexual exploitation.

Potential measures outlined in the forthcoming code may include age verification systems, default parental controls, and software solutions that filter or obscure inappropriate sexual content.

Representatives from major tech companies are responding to the call for action. spokesperson for Google, a subsidiary of Alphabet, indicated that the company is committed to collaborating closely with the industry to develop the new code. Meanwhile, a spokesperson for Meta, the parent company of Facebook and Instagram, affirmed that they are actively engaging with the eSafety Commissioner

While representatives from X (formerly Twitter) and Apple were unavailable for immediate comment, DIGI, an industry body representing major internet companies, expressed its eagerness to continue collaborating with the government and the eSafety Commissioner on this important initiative.

# The European Union Becomes a Full Participant in the Register of Damage for Ukraine

The European Union (EU) has officially advanced its role in the Register of Damage for Ukraine, transitioning from an Associate Member to a Full Participant. This move, welcomed by the European Commission, is a significant step in ensuring accountability for damages caused by Russia's war of aggression against Ukraine.

The Register of Damage, established on 12 May 2023 by the Council of Europe, serves as a repository of evidence and claims for losses, injuries, and damages sustained during the conflict. To date, 43 states, including 26 EU Member States, have joined the initiative, reinforcing international support for Ukraine's reconstruction.

#### **EU's Strengthened Commitment**

On 30 May 2024, the European Commission proposed upgrading the Union's status to a full Participant to enhance commitment to the Register. This change enables the EU to play a more active role in ensuring that violations international law by Russia result in proper compensation. Additionally, the EU has pledged an annual financial contribution, providing the Register crucial financial stability.



Didier Reynders, EU Commissioner for Justice, remarked, "Russia must pay for the damage caused by its aggression against Ukraine. The Register of Damage is a critical step towards securing compensation for Ukrainians affected by this war."

#### **Handling of Claims Begins**

As of April 2024, the first claims for damage or destruction of

residential property in Ukraine have been registered. The total claims in this category are expected to reach between 300,000 and 600,000. By August, additional categories of claims, including those related to critical infrastructure and war-affected individuals, will be open for submission.

The Register aims to ensure that all claims are securely recorded for future adjudication.

### **EU Takes Strong Steps to Safeguard Democratic Elections**

In December 2023, the European Commission adopted a new set of recommendations aimed at enhancing the integrity resilience of elections and across Europe. As part of the Defence of Democracy package, the Commission's recommendation on inclusive and resilient elections urges political parties to assess risks associated with foreign donations and contributions potentially linked to criminal activity.

Building this on recommendation, all European political parties have signed a code of conduct committing to avoid amplifying narratives

driven by entities outside the EU, especially those attempting to undermine European values.

#### Regulation 1141/2014 and the **Need for Reform**

The Commission and European Parliament evaluated Regulation 1141/2014 in 2021 and found overall positive results but acknowledged certain shortcomings. the Commission response, introduced a proposal to recast the regulation in November 2021. However, an agreement was not reached before the European Parliament elections. Discussions are set to continue during the new parliamentary term.

The EU has developed substantial expertise identifying and countering Information Foreign Manipulation and Interference (FIMI). A dedicated toolbox outlines strategies addressing these threats at the EU level, ensuring a robust defense against foreign interference democratic in processes.

## Advancements in Military Technology: Recent Defense Initiatives ByHenry Nicholas

### C-UAS Capabilities Testing at Yuma Proving Ground

In June, the Joint Counter-Unmanned Aircraft Systems (C-sUAS) Office (JCO) conducted its most ambitious field demonstration to date at Yuma Proving Ground in Arizona. Over four weeks, the JCO showcased prototype systems developed by various private firms, focusing on their effectiveness against drone This threats. year's demonstration emphasized countering attacks. swarm featuring a coordinated assault from 50 unmanned aircraft of different types targeting a single objective.

While the JCO continues to analyze data from this extensive exercise, an initial report will be distributed to military services, commanders combatant globally, and the eight participating vendors: Clear ICR, ELTA. Align, Trakka, Teledyne, FLIR, SAIC, ATSC, and Anduril. Col. Michael Parent, chief of acquisitions and resources at the JCO, noted, "No one capability, whether kinetic



or non-kinetic, in itself could really just beat this kind of attack profile. What we saw was they really do need a full system of systems approach, a layered approach." The next JCO field demonstration is tentatively scheduled for early 2025.

## Collaborative Combat Aircraft Program Update

In related developments, the head of General Atomics' aeronautics division informed Breaking Defense that flight tests for the prototype of the Air Force's Collaborative Combat Aircraft (CCA) program could begin by mid-2025. This

announcement follows the Air Force's decision in April to award the initial phase of the CCA contract to General Atomics and Anduril, bypassing major players like Boeing, Lockheed Martin, and Northrop Grumman.

Both companies will compete to develop uncrewed aircraft designed to engage fighter jets at a significantly lower cost than traditional crewed fighters. While General Atomics is tasked with delivering a limited number of CCAs for testing and development, the Air Force has indicated the possibility of acquiring over 1,000 drones

## Annual Competition for Small Unmanned Aerial Systems (sUAS)

The Defense Innovation Unit (DIU) is spearheading efforts to commercial incorporate technology, including small unmanned aerial systems (sUAS). This November, the DIU will launch an annual competition aimed at fostering innovation within the sUAS sector. Participants will have the opportunity to be included in the Defense Logistics Agency's (DLA) Blue UAS Cleared List, which features platforms and components vetted for security and compliance with U.S. laws and cybersecurity standards.

The competition seeks to keep the Blue List aligned with endaddressing user needs. modularity, issues such as interoperability, and operational capabilities contested in environments without GPS or reliable electromagnetic spectrum access.

### Pentagon Inspector General Reviews Hypersonic Threats

In July, the Department of Defense (DoD) Inspector General (IG) announced an investigation into the military's capacity to defend against hypersonic threats and the efficacy of the Combined Joint Forces Command Control (CJADC2) initiative. The IG's evaluation will assess the DoD's ability to use existing U.S. weapon systems for hypersonic missile defense amid rising concerns over advancements made by adversaries like China and Russia.

The investigation will also scrutinize CJADC2's effectiveness in modernizing information-sharing among mission partners.

## INDOPACOM to Receive Joint Fires Network (JFN)

By the end of 2024, the U.S. Indo-Pacific Command (INDOPACOM) will receive a "combat representative"

version of the Joint Fires Network (JFN), an initiative under the CJADC2 umbrella. This system aims to enhance command and control capabilities across multiple domains. especially amid growing tensions related to China's potential military ambitions in Taiwan.

The JFN will match weapons to targets in complex combat scenarios, and continuous upgrades are planned, with JFN 2.0 expected in 2025 to address the evolving demands of military operations.

### Executive Action on the Southern Border By Jan Frazier

In a significant policy shift, President Biden announced an executive order on Tuesday that from restricts migrants accessing the U.S. asylum the screening system at southern border. This action is triggered when undocumented border crossings average 2,500 per day, a threshold currently exceeded. As a result, asylum seekers will be unable to cross

until daily crossings fall below 1,500.

The executive order not only suspends the entry of non-citizens crossing the southern border without documentation but also aims to fortify the asylum screening process and enhance immigration enforcement. President Biden emphasized the need for this

proclamation. stating it address essential to the unprecedented levels of migration and improve the efficiency of processing migrants given current resources.

## U.S. Army Issues RFI for Software Development Support

In a move to bolster its technological capabilities, the U.S. Army has released Request for Information (RFI) for a new ten-year, multiple-award indefinite delivery/indefinite quantity (IDIO) contract. potentially valued at over \$1 billion. Managed by the Army Materials Command (AMC) and Army Contracting Command (ACC), this initiative seeks to procure software development support for military operations.

The contract will require the awardee to develop custom software products, modify existing systems, facilitate software as a service, and enhance software security and hosting. Responses to the RFI are due by June 10.

### Palantir Secures DoD Contract for Al Platform

The Department of Defense (DoD) has awarded Palantir a \$480 million contract for its prototype called Maven Smart System. This advanced AI intelligence-gathering platform consolidates data from various sources to pinpoint military points of interest and streamline the work of intelligence analysts. The contract is expected to conclude in May 2029.

Maven Smart Systems is currently operational across multiple commands, including the Joint Staff at the Pentagon and Combatant Commands such as Central Command and European Command. With this contract, the Pentagon may



expand Maven Smart Systems to additional Combatant Commands.

### U.S. Marines Acquire Tactical Robots

Amidst the growing demand for unmanned platforms, the U.S. Marine Corps has procured 200 tactical robots from Israeli company Roboteam for \$30 million. This order includes the 15-kilogram Micro Tactical Ground Robot (MTGR), a manportable system equipped with treads and a manipulator arm for object investigation, communication. and optics handling.

The initial order encompasses 130 units, with plans for Roboteam to complete the delivery of the full order of 200 by the first quarter of 2025.

### NATO to Enhance Intelligence Sharing with Ukraine

NATO member states. including the U.S., are set to bolster cooperation with Ukraine in defense technology and intelligence sharing regarding Russia's electronic warfare capabilities. A formal agreement outlining new information frameworks for sharing is expected to be finalized before the alliance's upcoming July Summit in Washington.

This initiative aims to transform Ukraine into a significant tech provider post-war while also allowing NATO to learn from Ukraine's rapid adoption and deployment of technology since the conflict began in 2021.

## European Political Community's Fourth Meeting: A New Era for UK-EU Relations

The fourth meeting of the European Political Community (EPC) is set to take place on Thursday at Blenheim Palace, marking a pivotal moment for the United Kingdom and its relationships with European nations. Launched in response to Russia's invasion of Ukraine in February 2022, the EPC is a collaborative initiative envisioned by French President Emmanuel Macron, designed to address shared concerns among European countries.

This summit, hosted by newly elected UK Prime Minister Sir Keir Starmer, will bring together approximately 50 European leaders, offering a significant platform for dialogue and cooperation. Starmer's leadership at this meeting represents his first engagement with international leaders since Labour's decisive victory in the General Election, highlighting a renewed commitment to reestablishing the UK's role on the global stage.

## Restoring Confidence and Building Bridges

The EPC serves as a forum for European nations, including the UK, to coordinate responses to common challenges, akin to the G7 or G20. With the backdrop of Brexit and its repercussions on the UK's international standing, this meeting is viewed as an essential opportunity Starmer to restore confidence British diplomacy and demonstrate that the UK is ready to engage with its European partners.

Notably, Russia and Belarus will not participate in the EPC discussions, having been excluded due to Russia's ongoing aggression in Ukraine, which Belarus has supported. In attendance will be key European leaders, including the presidents of the European.

Council, European Commission, and European Parliament. The new European Parliament will also vote on whether Ursula von der Leyen will continue leading the European Commission for another five years

## Perspectives on the EPC's Impact

Several prominent figures within the EU have voiced their expectations for the upcoming meeting. German centre-right MEP David McAllister, who chairs the influential foreign affairs committee in the EU emphasized Parliament, EPC's potential to strengthen UK-EU ties. He noted that the platform could facilitate dialogue on shared challenges, providing networking opportunities since UK officials no longer attend EU summits or preparatory meetings.

Sir Graham Watson, a former senior British Liberal Democrat MEP, remarked on the significance of the EPC for leadership. Starmer's He pointed out that the Prime Minister's commitment hosting the meeting and advocating for Ukraine could help mend the UK's reputation within Europe, especially given Starmer's previous statement ruling out a return to the EU's.

Polish deputy and former EU commissioner Danuta Hubner expressed cautious optimism about the EPC, stating that like-minded meetings of democratic states often vield outcomes. She positive highlighted the importance of the upcoming discussions on foreign and defense policy cooperation between the UK and EU, especially in light of the challenges posed by Russian aggression.

#### **Looking Ahead**

EPC meetings occur biannually, alternating between EU member states holding the EU Council and Presidency non-EU members. Previous summits have been held in Granada. Spain, Chisinau, Moldova, and Prague, Czechia. As the UK prepares to host this critical gathering. the upcoming discussions will not only focus

on immediate issues but also set the stage for long-term collaboration and stability in the face of ongoing geopolitical challenges.

The significance of the fourth EPC meeting cannot be understated. It represents a chance for the UK to reassert its influence in Europe, foster stronger ties with its neighbors, and work collaboratively towards a more secure.

They are actively monitoring the situation and consulting with partners in the region to understand the emerging needs arising from the conflict. "We will continue to collaborate closely with the American Society of Clinical Oncology (ASCO) through our Emergencies & Crises Network of 400 organizations worldwide to leverage global support for Ukraine's health and cancer care systems," they added.

The organization unequivocally labeled attacks on healthcare facilities as war crimes and called for immediate action to ensure that those responsible are held accountable. In their efforts to advocate for Ukraine. ECO intends to communicate with the new European Parliament European Commission, reiterating the urgent need for sustained financial support for country's healthcare infrastructure, particularly for maintenance and reconstruction of cancer.



ECO concluded with a powerful message: "Humanity must triumph over barbarity, and we all must play our part in achieving that."

# Haniyeh's Assassination: Implications for Middle East Stability and Ceasefire Negotiations

In the early hours Wednesday, Hamas leader Ismail Haniyeh was reportedly targeted in a missile strike, with Hamas swiftly attributing the attack to which has not vet commented on the incident. Haniyeh was in Tehran attending the inauguration of Iranian President Masoud Pezeshkian and was staying at a residence for veterans in northern Tehran. state-affiliated according to news sources.

Around 2 a.m. local time, Iranian state media outlet IRNA that reported an "airborne coached projectile" hit location where Haniveh was present, resulting in the death of one of his bodyguards. IRNA noted that further investigations are underway to determine the specifics of the operation, including the launch site of the projectile.

In response, Hamas condemned the strike, labeling it a "Zionist attack" and a "serious escalation" in its longstanding conflict with Israel. A Hamas official asserted the group is to "pay different prepared "This prices," declaring, assassination will not achieve the goals of the occupation nor will it compel Hamas surrender." ### Haniyeh's Background and Role in Hamas

Ismail Haniyeh, 62, hails from a refugee camp near Gaza City and joined Hamas during the First Intifada in the late 1980s. gained Hamas power, Haniyeh rose through its ranks and became part of its secret "collective leadership" in 2004. He was appointed the political leader of Hamas in 2017 and was designated "specially а designated global terrorist" by the United States in 2018.

Unlike many in Hamas' military command, Haniyeh traveled internationally, engaging with global leaders as the political face of the organization. He played a crucial role in negotiations during conflicts with Israel, especially concerning hostage and

ceasefire talks. Earlier this spring, he expressed Hamas' willingness to negotiate, contingent on Israel withdrawing from Gaza and committing to a permanent ceasefire—conditions Israel deemed "unacceptable."

#### Potential Consequences for Ceasefire Negotiations

Haniyeh's recent communications with mediators from Qatar and Egypt indicated progress toward a framework agreement, but assassination could severelv disrupt these discussions. Sources suggest that Haniyeh was vital in achieving breakthroughs in negotiations and was considered a key decision-maker alongside Yahya Sinwar, the Hamas military commander in Gaza.

Oatar's Prime Minister Mohammed bin Abdulrahman Al-Thani, who has been involved in mediation efforts. concerns about the implications of Haniveh's assassination for negotiations. questioned the feasibility of peace talks when one party targets the other's negotiator, emphasizing the need for serious commitment to peace and a stance against disregard for human life.

### Global Reactions to Haniyeh's Assassination

The assassination has drawn reactions from leaders across the region, many of whom condemned the act and expressed concern over its potential ramifications. Palestinian leaders, despite

historical conflicts with Hamas, denounced the killing and called for Palestinian unity.

The White House acknowledged reports of Haniyeh's death but refrained from making further comments. U.S. Defense Secretary Lloyd Austin stated he does not believe war in the Middle East is inevitable but affirmed that the U.S. would support Israel if attacked.

Internationally, leaders from Russia and Turkey condemned the assassination, warning it could escalate tensions in the region. Support for Haniyeh also emerged from Iran-backed militant groups like Hezbollah in Lebanon and the Houthis in Yemen. signalling broader implications for regional stability.

## The Ongoing Crisis in the Middle East and North Africa By Randy Whitehead

The conflict in the Middle East and North Africa remains dire, with renewed efforts for a ceasefire between Israel and Hamas in Gaza. As the world watches and hopes for peace, the violence continues unabated, resulting in tragic loss and displacement. life Recently, Israeli forces have intensified operations in areas where Hamas has reestablished a presence, leading to further suffering for already displaced individuals. The intensity of the shelling in Gaza City has surged, with 116 hostages still

unaccounted for since their abduction by Hamas.

#### A Community in Crisis

Among the small Christian community in Gaza, estimated at around 1,000 individuals, about one-third have either fled the region or lost their lives in the ongoing conflict. The Holy Family Church has become a refuge for approximately 600 people. However, the church compound was hit by an Israeli airstrike last week, targeting classrooms and resulting in the

deaths of four people, including a Hamas labor minister.

In a poignant appeal for peace, 12-year-old Faeqa Ayyad, sheltered in the Holy Family Church, expressed her desire for the conflict to end during a live broadcast on SAT-7. She recounted the fear experienced by her younger siblings and implored for a return to normalcy, where children could play and enjoy their youth.

The Latin Patriarchate of Jerusalem has condemned the attack, calling for an end to actions that jeopardize civilian safety. Recently, the cardinal Patriarchate's had visited the local community. aiming to support and uplift them during these trying times. The airstrike on the Holy Family Church coincided with a major Israeli offensive in Gaza City, which also led to the closure of the church-run Al Ahli hospital. The area was designated a Red Zone, and patients had to be evacuated to the already strained Indonesia Hospital. Both Jerusalem Archbishop Hosam Naoum and Archbishop of Canterbury Justin Welby voiced their opposition to the hospital's closure. Fortunately, reassurances were given by the army that the hospital could reopen.

#### **Escalating Tensions in Lebanon**

Concerns are mounting that the conflict between Israel and Gaza could spill over into Lebanon. Since the beginning of October, Hezbollah, the Iranbacked militant group, has engaged in skirmishes with Israeli forces, offering support to Hamas. This has led to significant evacuations on both sides of the border.

Lebanon's political leaders, already grappling with a severe economic crisis and the aftermath of the 2020 Beirut port explosion, are anxious to avoid further conflict. Prime Minister Najib Mikati stated that another war "is in no one's interest." Over the past five years, around half a million Lebanese have emigrated, and



the potential for war country's Christian community, in particular, has voiced strong opposition to Hezbollah's actions. In a recent incident. residents of Rmeich. predominantly Christian town, successfully forced Hezbollah operatives to dismantle a rocket homes, ringing church bells to rally community support.

#### Humanitarian Crisis in Sudan

In Sudan, the humanitarian situation is deteriorating rapidly, with three-quarters of a million people on the brink of famine, according to outgoing UN aid chief Martin Griffiths. Catastrophic conditions affecting 8.5 million individuals, while approximately 9 million

is have been displaced due to the exacerbating this trend. The ongoing conflict between the Sudan Armed Forces and Rapid Support Forces Thousands continue to flee as spreads. fighting Recently, a representatives from the armyaligned government refused to participate in peace talks with civilian leaders, including the launcher set up near their former prime minister, in Cairo. This month, new efforts to negotiate a ceasefire are set to begin through a committee of African heads of state on behalf of the African Union.

### The Tragic Case of Muhammed Bhar in Gaza

In a harrowing incident that drawn international 24-vear-old attention. Muhammed Bhar, a Palestinian man with Down syndrome, was reportedly left to die by Israeli soldiers after being attacked by militarv dog during operation in Gaza. This tragic event has raised serious questions about the treatment of civilians in conflict zones and the responsibilities of military forces.



On July 3, 2023, Israeli soldiers raided the Bhar family's home in the Shujaiya neighborhood of eastern Gaza City. During the operation, combat dogs were unleashed, leading to a brutal attack on Muhammed. His mother, Nabila Bhar, recounted the horrifying moment when the dog mauled her son while she pleaded for mercy, emphasizing his vulnerability due his disability.

The Israeli has army acknowledged that after the attack, soldiers abandoned Muhammed to assist fellow soldiers injured in a separate incident involving a rocketpropelled grenade (RPG) attack. The family was ordered to evacuate their home at gunpoint, leaving Muhammed behind in a separate room



bleeding.

#### Family's Desperation and **Aftermath**

In the days following the incident, Nabila and other family members desperately contacted the Red Cross. seeking assistance for Muhammed. However, they were informed that the Israeli army was not cooperating with their requests for medical help. Tragically, it wasn't until a week later that the family was able to return to their home, only to find Muhammed's decomposing body covered in blood and infested with worms.

Jebril Bhar, Muhammed's brother, described the scene upon their return: "He was lying on his stomach... based on the state of his body, it was evident he had died several days earlier." The family had no means to transport his body for

where he was left alone and burial due to the devastation caused by ongoing military operations in the area. Consequently, they buried him near their home.

#### Reactions and Calls for Accountability

The incident has sparked outrage among human rights advocates and organizations. calling for Many are independent investigation into the circumstances surrounding Muhammed's death and broader concerns regarding civilian during military safety operations. The Israeli military stated that they "regret the harm to civilians," but this acknowledgment has done little to assuage public anger over the treatment of vulnerable individuals like Muhammed.

Nabila Bhar expressed her profound grief and disbelief

over her son's tragic fate: "I cannot bear to think of what they did to him or how they left him to die like this." Her account reflects not only personal loss but also highlights systemic issues related to military conduct in conflict zones.

#### Conclusion

The case of Muhammed Bhar serves as a stark reminder of the human cost of conflict and raises critical ethical questions about military engagement in civilian areas. As calls for accountability grow louder, it is

imperative that all parties reflect involved on their responsibilities toward vulnerable populations during times of war. The tragic loss of Muhammed Bhar will not be forgotten as his family continues to seek justice for his untimely death.

## Declining Vaccination Rates in the MENA Region Threaten Children's Health By Randy Whitehead

Millions of children across the Middle East and North Africa (MENA) remain at risk preventable diseases due to a significant decline in vaccination coverage. According the latest WHO and UNICEF estimates (WUENIC), released in 2023, the number of "zero-dose" children-those who have not received even the first dose of the diphtheria, tetanus, and (DTP) vaccine-has pertussis surged to a staggering 1.64 million. This represents a sharp increase from 1.2 million in 2022 and more than double the 872,000 zero-dose children reported in 2019.

UNICEF Regional Director for MENA, Adele Khodr, expressed alarm over the growing number of under-vaccinated children, warning of the real threat posed by diseases that could be prevented through vaccination. The MENA region ranks sixth out of seven UNICEF regions for DTP1 vaccine coverage, which fell to 85 percent in 2023—down seven percentage points from 2019.


Conflicts and humanitarian crises are among the primary drivers of this worrying trend, with war-torn countries like Sudan. Yemen. and Syria accounting for nearly 87 percent of the zero-dose children in the region. Sudan alone is home to 42 percent of these children. Even in traditionally highcoverage countries such as the State of Palestine, conflict has started to erode immunization rates, and the ongoing violence in Gaza threatens to worsen the situation in 2024 unless urgent action is taken.

Measles vaccination rates also suffered. with have coverage dropping by percentage points since 2019, leaving almost 2 million children in MENA without their first dose the vaccine. vaccination coverage varies across the region, 13 out of 20 countries have maintained a coverage rate of 90 percent or Encouragingly, middle-income countries showing signs of recovery from the disruptions caused by the COVID-19 pandemic, putting them on track to meet the goals

of the Immunization Agenda 2030.

Khodr emphasized the need for governments to prioritize investments in health systems and ensure that every child receives the necessary vaccines. She highlighted also importance of supporting frontline workers and ensuring safe humanitarian especially in conflict zones, to prevent further backsliding in immunization efforts.

If the region is to protect its children from preventable diseases, urgent action is needed to reverse these declining vaccination rates.



## U.S. Envoy Backs Israel's Right to Defend Itself at UN Security Council By Randy Whitehead

The U.S. representative to the United Nations has voiced strong support for Israel's right to defend itself against Hezbollah and other militant groups during a recent address at the UN Security Council. His remarks came as tensions escalated in the region following an Israeli airstrike on Beirut that resulted in the death of Fuad Shukur, a senior Hezbollah commander.

While affirming Israel's defensive actions, the U.S. envoy made it clear that the United States had no involvement in the airstrike. His speech underscored the need for global solidarity with Israel as it confronts continued attacks from Hezbollah, urging the Security Council to send a strong and unified message against the militant group.

The envoy also highlighted concerns about the increasing influence of Iran-backed groups in the region, particularly the Houthi rebels in Yemen, who been exploiting ongoing conflict in Gaza to further destabilize the Middle East. He stressed importance of standing firm against threats to regional stability and pointed to the broader U.S. strategy countering Iranian influence, while supporting Israel's actions to neutralize perceived security risks.
