



U.S. government shuts down after Senate budget failure

Five votes short of the 60-vote majority needed to pass, the legislation was defeated by a vote of 55-45.

Senators John Curtis and Mike Lee of Utah both supported the financing bill with their votes. Curtis blamed the unsuccessful vote on "Washington's dysfunction," while Lee specifically attacked Democrats for the closure.

While Republicans made "every accommodation" to the Democrats, Sen. Lee claimed in a video uploaded to his personal X account that they were "utterly unwilling."

"This is really an unfortunate step they are taking and I think they will come to regret it. But it is what it is, and we will move forward,"

Lee said. Lee later added on his official account that Democrats' "hostage-taking with government funding will not succeed."

Curtis said he is deeply concerned about relying on what he called "short-term Band-Aid" solutions. "Shutdown showdowns are no way to run the greatest nation on Earth,"

Curtis said.

"Utahns know the simple truth: you prepare, you live within your means, and you finish the job. My mission is to work with colleagues on both sides of the aisle to build a process that reflects those

principles, one that ends the cycle of crisis management and restores public trust."

After the vote, Senate Minority Leader Chuck Schumer said Democrats were working to negotiate an extension of the Affordable Care Act and to reverse cuts to Medicaid. He said data showed it was one of the most important things to the American people.

"So, we want to sit down and negotiate, but the Republicans can't do it in their partisan way," Schumer said.

However, Utah Rep. Burgess Owens, who represents the state's fourth congressional district, called the shutdown "The Schumer Shutdown," laying the blame on the minority leader.

"Chuck Schumer and the Democrats would rather pick a fight with President Trump than keep the government open,"

Owens wrote on social media.

Owens was joined on X by Rep. Mike Kennedy, who stated that the shutdown could and ought to have been avoided.

Representatives Blake Moore and Celeste Maloy, who both supported the bill that ultimately lost in the Senate, have not yet responded.

The shutdown is likely to result in the furloughing and termination of a number of federal employees. Until financing is authorized, other federal operations will be suspended.

Utah's Mighty 5 National Parks Arches, Bryce Canyon, Canyonlands, Capitol Reef, and Zion will continue to be open and accessible in spite of the closure. In addition, the Utah Department of Health and Human Services stated that its programs will remain open despite the federal shutdown.

How many federal workers will be furloughed and who gets paid?


About 750.000 federal employees are anticipated to be furloughed through the U.S. government shutdown, meaning they are immediately sent home without That pay. approximately 23% of the federal workforce. Furloughed employees will not receive paychecks during the shutdown but are eligible to receive back pay when funded government reopens. according the Government Employee Fair Treatment Act of 2019.

In addition, the roughly 1.5 million federal workers who are "excepted" or "essential" will still work without compensation.

This group includes federal law enforcement agents (including ICE, TSA, and Department of State agents), air traffic controllers, FBI and CIA agents, active military personnel, and others under federal duties protecting life and property.

Republicans and Democrats blamed each other for health care and expenditure in the runup to the vote.

Republicans said they can reopen the government on Wednesday if just five Democrats join the GOP "to pass the clean, nonpartisan funding bill that's in front of us." Senate Majority Leader John Thune begged Democrats to do so.

"Democrats have officially shut down the federal government. They're putting illegal aliens FIRST and hurting hardworking Americans in the process,"

a post from the House Republicans X account read. On Wednesday, about ten hours into the shutdown, the White House declared the Democrats'

regard for Americans - has slammed the brakes on the U.S. government."

"They are holding the nation HOSTAGE to appease their radical left base. This is the DEMOCRATS' DISASTER," the post continued.

Meanwhile, top Democratic leaders Chuck Schumer and Hakeem Jeffries accused Republicans of lying.

"Republicans JUST VOTED DOWN our bill to avoid a government shutdown at midnight address and the healthcare needs of the American people," Schumer explained on X.

"Republicans are plunging us into a government shutdown rather than fixing their healthcare crisis."

While Trump and Republicans shut down the government "because they want to take your healthcare away," Jeffries told Good Morning America, Democrats are fighting to

safeguard healthcare.

Kamala Harris, the former vice president, shared her thoughts on social media.

"Let me be clear: Republicans are in charge of the White House, House, and Senate. This is their shutdown."

Which Cabinet agencies released shutdown contingency plans first?The Department of Defense put out one of the most detailed plans, which indicated that around 406.500 out of its civilian workforce of total 741.500 would continue to work without pay while the remainder would be furloughed. Similarly, the nation's nearly 2.1 million personnel military continue to report for duty, but would not be compensated until shutdown. the Defense suggested certain operations would be prioritized and even evaluated, focusing on missions related to border security, military presence in Middle East, urgent munitions, and shipbuilding.

For example, some agencies, including the Social Security Administration and the EPA, had shared their plans on their websites early. However, a number of agencies had yet to post an updated plan on their websites as of late September, including the Departments of Agriculture, Commerce, Energy, HUD, Interior, State, Transportation, and Veterans Affairs.



White House withdraws BLS nomination amid concerns



rika McEntarfer was sacked by Donald Trump in August after the bureau released adjustments to its monthly jobs report that revealed sluggish job growth over the summer. To replace her, Trump selected EJ Antoni, a coauthor of Project 2025 and top economist at the conservative Heritage Foundation.

Both liberal and conservative economists expressed a rare agreement upon Antoni's nomination, arguing that he was too politicized to fill the position. Antoni was a vocal opponent of the agency

prior to his candidacy, implying without proof that its data reporting was biased.

The retraction of Antoni's nomination was deemed "good news in and of itself" by Stan Veuger, a senior fellow at the conservative American Enterprise Institute.

"Antoni was genuinely unqualified and had clearly been picked based on his willingness to produce highly partisan content,"

Veuger said.

"That said, it remains to be seen what comes next."

The reason behind the White House's decision to withdraw Antoni's nomination has not been disclosed. To formally assume the position, Antoni would have needed Senate confirmation. According reports, it would have been difficult Antoni's to get nomination through the chamber because key senators, including Republicans Susan Collins and Lisa Murkowski, had declined to meet with him. The Senate "appears to have

done its job and made it clear it would reject someone who was exceedingly unqualified for the job of BLS commissioner," according to Harvard economist Jason Furman.

"I hope they go even further and demand nothing less than someone who is very qualified for the job. We will see,"

he added.

In a statement, the White House said that Antoni "is a brilliant patriot that will continue to do good work on behalf of our great country".

"President Trump is committed to fixing the longstanding failures of the BLS that have undermined the public's trust in critical economic data," the White House said.

"The president plans to announce a new nominee very soon."

In a social media post after the White House withdrew Antoni's nomination, the Heritage Foundation's president, Kevin Roberts, said that "it was undeniable that the BLS needs reform and [Antoni] was the right man for the job".

"Antoni continues to be one of the sharpest economic minds in the country. EJ's immense capabilities and insightful economic analysis have not changed – and we're very proud to have him on our team," Roberts wrote.

Trump accused the bureau of "rigging" its July employment report against him when he fired McEntarfer, claiming that the bureau had exaggerated the number of new jobs added to the economy by 250,000. However, the bureau claimed that the updates were provided by companies who responded to its surveys, which it utilizes to gather data that is received later, which is typical during unstable economic times.

Economists have generally stated that the bureau remains impartial in spite of Trump's attacks, stressing the need of having faith in the agency because it provides data that influences markets and policy choices, such as the state of the job market and inflation.

"The BLS is the gold standard around the world for reliable and accurate economic data."

Herbert added.

"Their integrity and independence must be protected if they are to maintain their status as the premier source of economic data in the world today."

Michael Madowitz, an economist at the liberal Roosevelt Institute and a former member of the data users advisory committee at the BLS, said that the agency, when it's doing its job properly, should be

"beneficial and boring".

"There are parts of the US government that do economic policy and parts that do public," Madowitz said.

"The concern until last night was putting ideological policy folks in charge of the plumbing, which would create lasting chaos."

What did leading economists specifically say about Antoni?

Antoni characterized as a conservative ideologue rather than a precise economist studying accuracy based on a history of manipulating data to bolster politically-driven accounts that aligned with President Trump.


He falsely asserted that the U.S. economy was in a recession since 2022 based on inflated measures of housing prices.

Economists remarked that Antoni had a tendency to misimply statistics like labor force participation rates and import prices, while often ignoring the broader economic context of falling population which growth rates. had ramifications for economic growth.

He also suggested extreme paradigms, like ending Social Security payments to workers, which drew concerns due to the BLS supervising adjustments related to inflation that affect beneficiary payments.

Trump slams Canadian anti-tariff ad as 'crooked'



he provincial government of Ontario sponsored the ad, which criticizes <u>U.S. tariffs</u> by using actual but edited clips from a Reagan speech in April 1987 regarding placing tariffs on Japan.

"Canada lied,"

Trump told reporters Friday as he prepared to depart for an Asia trip.

"They made up a fake statement by President Reagan. Reagan was a big supporter of tariffs when needed. We need tariffs for national security, and they totally turned it around because they're getting hurt by tariffs, and we're gaining by tariffs."

Trump continued,

"Reagan liked tariffs and when necessary, he would use tariffs, It's made us a very rich country. It's also made us, when it was used against us, not good for us. But we've used them very successfully."

Trump responded by declaring on Thursday that he was

terminating all trade talks with Canada.

The Reagan Presidential Foundation denounced the advertisement as unlawful and a distortion of Reagan's beliefs. The charity stated that it is looking into legal alternatives regarding the audio's use.

Trump reiterated these worries, claiming that Canada was attempting to sway a future ruling by the US Supreme Court about his expansive tariff plan. After meetings with Canadian Prime Minister Mark Carney, Ontario Premier Doug Ford announced on Friday that he will remove the advertisement to allow trade negotiations to resume.

Ford said the campaign's goal was to spark dialogue about the impact of tariffs on workers and businesses.

"We've achieved our goal, having reached U.S. audiences at the highest levels."

Ford said in a statement Friday.



"Our intention was always to initiate a conversation about the kind of economy that Americans want to build and the impact of tariffs on workers and businesses."

What trade talks were halted after the ad?

The trade addresses that were halted by President Donald Trump after the controversial Canadian anti-tariff announcement involved ongoing accommodations between the United States and Canada regarding tariffs and programs. Trump announced the termination of all trade conversations with Canada, citing the Ontario government's announcement which featured extracts from a Ronald Reagan speech censuring tariffs.

Trump indicted the announcement of being fraudulent and designed to intrude with a pending U.S. Supreme Court case concerning his authority to put tariffs on foreign products. This led to the immediate conclusion of trade accommodations that had been progressing in the environment of tariff controversies and profitable cooperation between the two countries.

The addresses were part of broader efforts to resolve trade pressures following the duty of tariffs on Canadian goods by the U.S. administration before in 2025.

The list also includes billionaire Trump supporters who contributed significantly to his campaign the previous year. In a letter sent to the White House chief of staff, Susie Wiles, Schiff and his colleagues warned that the Trump administration's approach "raises troubling questions about the potential for influence peddling and other forms of corruption".

"To assess possible conflicts of interest and violations of law and ethics obligations, Congress and the American public deserve meaningful transparency. We, therefore, request a complete accounting of all donations to the White House ballroom construction project, including the conditions under which contributions were made,"

wrote the senators.

A comprehensive account of donations, including quantities, dates, and if benefactors have connections to civil anv contracts, nonsupervisory blessings, or government suits. is what the legislators are requesting. Also, they want to whether the administration sought ethics advice prior to taking on private cash and whether there are any masures in place to keep benefactors from having preferential access the to chairman.

Legislators Alex Padilla, Richard Blumenthal, Chris Van Hollen, Tammy Duckworth, Jon Ossoff, Bernie Sanders, and others have inked the letter, which asks the White House to deliver the data by November 5.

A complete list of all individual and commercial benefactors, their benefactions to the Trust for the National Mall or through circular channels, and information about any conditions attached to gifts are among the specific effects requested.

What legal rules govern private funding of White House renovations?

This civil law prohibits spending government finances without congressional appropriations. Legal experts argue that counting heavily on private donations may violate this act if it circumvents proper budgetary approval.

Private donations for government structures full public generally bear exposure of patron individualities and quantities to insure responsibility and avoid conflicts of interest. There are calls for strict oversight to help overdue influence or "buying access" to the administration.

What are the main differences between Blinken's and Trump's Gaza plans?

Blinken's plan showcases the Biden administration's post-war management strategy for Gaza that has been in the works for months. The plan features a reformed Palestinian Authority (PA) representing both the West Bank and Gaza with the process forming а transitional government with international support.

It also proposes a security force with both vetted members of the PA and international officers, designed to avoid the resurgence of Hamas.

Blinken emphasizes it is vital to provide a "credible political horizon" for Palestinians, while promoting governance reconstruction while preventing further insurgency.

It was mentioned that Israel would determine when or if it would withdraw completely. However, Blinken emphasized that in doing this responsibly, Israel would have certain caveats and conditions related to security that could postpone Israel's ultimate withdrawal.

Hamas seeks revisions but likely to accept Trump Gaza plan

n order to end the two-year conflict in Gaza and for an ostensibly prolonged international administration of the destroyed territory, Trump gave Hamas "three or four days" starting Tuesday to respond to his 20-point plan, or "pay in hell."

Hamas must now "choose between the bad and the worst," according to Gaza political scientist Mkhaimar Abusada, who is based in Cairo.

"If they say 'no', as Trump has made clear, that will not be good and will allow Israel to do whatever it takes to finish this. They will say "yes, but we need this and that",
Abusada said.

Hugh Lovatt, a senior fellow at the European Council on Foreign Relations, said it would be very difficult for Hamas to accept the terms unconditionally.

"That is understandable. The text lacks details. But then anything other than total and final acceptance will be used against Hamas by Israel, the Trump administration and possibly the Europeans,"

he said.

Prime Minister Benjamin Netanyahu of Israel has <u>agreed</u> to the Trump plan, which was developed without consulting Hamas and includes several of Israel's main demands.

Israel would "finish the job" Hamas rejected the prosocior of delayed its implementation, according to Netanyahu, who is wanted by the international criminal court for suspected war crimes committed during the Israeli offensive in Gaza. Israel unilaterally halted a two-month truce in March, delaying the start of a second phase that would have put an end to hostilities for good.

Discussions over the group's response are made more difficult by the fact that Hamas officials are split between Gaza, Doha, and Istanbul. Hamas is under pressure from Qatar and Turkey to compromise.

One sticking point is the plan's demand that Hamas disarm, a source close to the organisation said. The surrender of all weapons would be very difficult for Hamas to accept, especially without any political process or substantial progress towards a two-state solution.

"There are different trends within the movement. The membership in Doha tends to be more pragmatic, especially compared to the military leadership in Gaza. There is an obvious need to have the buy-in of the military win, and the rank and file fighters,"

This backdrop created imperative pressing for stakeholders to pursue ceasefire agreements and devise sustainable peace plans to end hostilities, ensure the release of and provide hostages, humanitarian relief to affected populations.

The prolonged conflict also heightened global attention on the longstanding Israeli-Palestinian dispute, calling for renewed diplomatic engagement with the involvement of international mediators such as the United States, Qatar, Turkey, and Egypt.

The role of US, Qatari, and Turkish officials in Egypt ceasefire talks

In October 2025, indirect peace talks between Israel and Hamas were held in Sharm El-Sheikh, Egypt, facilitated by a coalition of international actors including the United States, Qatar, and Turkey. These talks represent some of the most consequential diplomatic efforts since conflict's the outbreak. The United States has played a leading role, driven by the peace plan proposed by President Donald Trump September 2025-a 20-point ceasefire framework aiming to halt violence, secure the release of hostages, and rebuild Gaza under international supervision.

Oatari officials have long acted mediators in the Israeli-Palestinian conflict due to their unique relationships with Hamas and regional countries, working closely with Egypt as the host nation organizing negotiations. Turkey's involvement provided additional diplomatic an dimension, leveraging influence with certain regional Islamist movements and expressing a commitment to peace and humanitarian aid.

These diplomatic efforts aim to address key political and security challenges, including disarmament of militant groups, recognition of political authority in Gaza, prisoner exchanges, and toward Palestinian governance reform. The talks have been conducted indirectly avoid political risk and maintain dialogue channels between the adversarial parties. Senior envoys from the U.S., Oatar, and Turkey coordinated negotiations and sought consensus on difficult issues, Israel's balancing security concerns with demands for humanitarian access and political inclusion for The Palestinians. meeting underscored regional cooperation and demonstrated the strategic importance of Egypt as a peace broker in the volatile Middle East landscape.

The US-Israel Dynamic in Gaza peace negotiations

The United States, under President Donald Trump's

leadership in 2025, has strongly supported Israel while simultaneously advocating for a negotiated peace framework to end the Gaza war. The Trump administration unveiled comprehensive 20-point peace proposal that envisioned Gaza as a demilitarized zone with no capacity to launch attacks on Israel. Key provisions of the plan include the immediate cessation of hostilities, phased withdrawal of Israeli forces from parts of Gaza following hostage releases, new governance framework under international aimed supervision reconstruction and humanitarian relief. The plan also proposed an amnesty for Hamas official members renouncing violence and consenting to disarmament, along with options for safe passage out of Gaza for those desiring to leave.

Israeli Prime Minister Benjamin Netanyahu publicly endorsed pledging full U.S. the plan, support to "finish the job" if Hamas rejected the This arrangement. stance reflects Israel's dual approach of military pressure combined with diplomatic negotiations facilitated by the U.S. The negotiations underscore complexity of balancing Israel's security imperatives with the humanitarian and political conditions on the ground in Gaza. While the peace plan received backing from many

Western and Middle Eastern governments, Hamas's response

cautiously was optimistic, agreeing to some terms such as hostage release but resisting full disarmament or international governance control. This cautious stance by Hamas prolongs uncertainty highlights ongoingobstacles to a final peace deal. The U.S.-Israel alliance continues to be central to conflict resolution strategies, leveraging diplomatic influence and aid to push toward sustainable cessation hostilities.

Humanitarian and reconstruction efforts embedded in peace talks

Central to the 2025 ceasefire discussions are plans for comprehensive humanitarian relief and reconstruction in the Gaza Strip, areas ravaged by combat and blockade conditions. The peace proposals include detailed commitments for the delivery of food, water, medical supplies, and infrastructure restoration. Agreements signed earlier in January 2025 by regional stakeholders outlined frameworks to rehabilitate essential services, including water and electricity, sewer systems, hospitals, roads, and schools, recognizing the acute humanitarian needs faced by the civilian population. International aid agencies, coordinated through UN channels and supported by regional governments, prepared for large-scale deployment of resources upon a ceasefire's implementation.

The peace plan, and ongoing negotiations, underscore that

reconstruction will require careful attention to security and governance challenges, ensuring materials do not support renewed militant activities. This linkage creates a political and challenge monitoring aid and rebuilding while fostering economic recovery and social stability. Humanitarian corridors remain a contentious issue. with all parties seeking guarantees against exploitation for military The inclusion purposes. humanitarian priorities in the peace process represents modern approach aiming not just to end fighting but to rebuild communities and create sustainable peace conditions, benefiting both Palestinians and Israeli security through reduced and economic tensions opportunity.

Prospects and challenges for a durable Gaza peace agreement

Despite intensive diplomatic efforts, the prospects for a durable Gaza peace deal remain contingent on numerous complex factors, including political will, intra-Palestinian reconciliation, and regional dynamics. The multifaceted nature of the Israeli-Palestinian conflict. compounded decades of mistrust, territorial disputes. and external influences, complicates pathway agreements. The 2025 ceasefire talks represent renewed attempt leverage to international mediation mechanisms and bold proposals

to break stalemates.

Achieving lasting peace requires addressing security, political representation, humanitarian needs, and the contentious issue Gaza governance, Hamas's role central to the resolution's acceptance. The plan calls for disarmament and international oversight, which remains a major sticking point. Additionally, regional actors like Egypt, Qatar, and Turkey face balancing their own political while facilitating negotiations to avoid escalation. The United States and Israel's firm posture ensures continued pressure for concessions, but comprehensive buy-in from all parties remains challenging.

Furthermore, the peace process intersects with broader Middle East peace initiatives, including normalization agreements, relations with other Arab states, and the Palestinian Authority's roles in the West Bank. The regional ecosystem of alliances and disputes greatly influences implementation. actual International support, including from the UN, EU, and Arab League, remains vital to provide legitimacy and resources. For the people of Gaza and Israel alike, the hope is that diplomatic breakthroughs in 2025 can pave the way to an enduring peace that ends cycles of violence and suffering, although the road ahead is fraught with difficulties requires sustained commitment from all stakeholders.

Huckabee, who sat among top U.S. officials watching the stage, waved and gave the panel the thumbs up.

As Ohana welcomed the politicians to the parliament building, they turned to face Hegseth and the Chairman of the Joint Chiefs of Staff, Dan Caine.

Together with Witkoff and his spouse, Kushner and Ivanka were greeted for their representation of the U.S. delegation during the conflict between Israel and Hamas.

Ivanka was seated in the middle of the U.S. contingent, looking over the podium.

Speaking in Hebrew during his introductory remarks, Ohana quoted Witkoff as saying that "we wouldn't have reached this point

if Prime Minister Netanyahu hadn't acted the way he did" and commended Netanyahu for making "very difficult decisions." When the president arrived Monday to speak to the parliament and hear from top Israeli officials, he received a two-and-a-half-minute standing ovation.

The speaker called Trump "one of the most consequential presidents in history" and promised to work with U.S. House Speaker Mike Johnson to support Trump's bid for the Nobel Peace Prize the following year.

"There is no one more deserving than you, President Trump. No one!"



How do other countries regulate press access defense to ministries?

Access to defense ministries by the media differs significantly between countries. balancing national security with media freedom.

For instance, press access to the UK Ministry of Defence relatively unrestricted. Accredited journalists regularly attend briefings. attend conference and visit military operations where ground rules are organised. Journalists must have security clearances to enter sensitive areas, but outside of that, press access is normally unrestricted if they operate under transparency protection ensure security of operations is not compromised.

"Secretary Hegseth and I had previously met in Singapore and today was the opportunity for a substantial discussion about conflicts around the world as well as more opportunities for the US and New Zealand to work together,"

President Donald Trump criticizes military's 'good looks'

hile speaking to sailors on board the U.S. George Washington, a Nimitz-class aircraft carrier stationed semi-permanently at the U.S. naval base in Yokosuka, Japan, Trump interrupted his attempt to commend gathered service members to babble about their overly attractive appearance.

Trump said the Navy's "ultimate strength" comes from "the men and women of the rank and file" on the second day of a multi-day, multi-country trip through Asia that will end on Thursday

following a scheduled summit with Chinese leader Xi Jinping. He referred to his uniformed audience as "incredible people" and "good-looking people."

After a beat, he said there were "too many good-looking people" present.

"I don't like good-looking people," he continued, as the sailors laughed at their commander-inchief's bizarre remark.

"I never liked good-looking



people, I'll be honest with you ... never admitted that before,"

he said.

Following a theatrical arrival at the George Washington, which is

forward-deployed in Japan as part of the permanent American military presence there under a 1960 joint defense treaty that superseded an earlier agreement imposed as a condition of ending the post-World War II occupation of Japan by U.S. forces, the president delivered his rambling, spontaneous remarks.

Before launching into a tirade of grievances regarding the elevator and catapult systems aboard the newest class of American carriers, beginning with the class' lead ship, the U.S.S. Gerald R. Trump made his entrance on one of the aircraft carrier's enormous elevators, which are used to transport planes and helicopters from hangars to the carrier's enormous flight deck.

Trump's Caribbean military Op faces hurricane test

s the Trump administration launches strikes against suspected drug smuggling vessels that have killed more than 50 people since early September, eight warships with over 6,000 troops and several dozen planes are currently gathered in the area.

However, since the hurricane is expected to be the strongest storm on record, many of the staff members on these warships are also trained to respond to natural catastrophes and may readily offer assistance, according to The Washington Post.

Forecasters warn that Hurricane Melissa, a strong Category 5 storm, will become a "very dangerous and life-threatening situation" after making landfall in Jamaica on Tuesday. Destructive gusts of 185 mph have been unleashed by the hurricane, which is predicted to dump up to 30 inches of rain on the Caribbean nation.

Whether or how the United States will intervene to support Jamaica during the destructive storm is still up in the air. The president has been under fire for his prior storm responses, particularly his handling of storm Maria in Puerto Rico in 2017. Those close to Trump claimed that although he praised the U.S. reaction as a success, he had been slow to act and was hesitant to assist Puerto Rico, a U.S. territory.

According to a State Department official who spoke to the Post on condition of anonymity, the

organization has prepared emergency assistance materials in six warehouses for distribution to storm victims.

According to the official, "additional capability will not be deployed until a need is identified."

The source claims that when it is in the best interests of the United States, the government can offer "lifesaving assistance to affected countries and people across the country."

Bryan Clark, a retired Navy officer, told the publication that the United States can continue its purported counternarcotics mission off the coast of Venezuela while simultaneously assisting Jamaica.

"The question will be: Does the administration take advantage of that, or does it use this as a statement regarding its priorities?"

he said.

"If it chooses to keep the naval force focused on Venezuela rather than disaster response, it would certainly show how the administration wants to exercise its defense priorities."

What legal limits apply to strikes in international waters during hurricanes?

The United Nations Convention on the Law of the Sea (UNCLOS) establishes that transnational waters (high seas) are free for navigation and use by all countries but are reserved for peaceful purposes. The use of military force is allowed only in exceptional circumstances similar to tone- defense or with UN Security Council authorization.

A vessel on the high seas is under the governance of its flag state; force can only be used against it with a clear legal base similar to pirating, slave trafficking, or if the vessel is stateless. The UN Charter limits use of force to tone- defense in response to a fortified attack, taking necessity and proportionality. There's no specific impunity or different rule for use of force during hurricanes, but functional prudence generally prevails given storm hazards and philanthropic precedences.



US Pentagon approves long-range Tomahawks for Ukraine

ven during the first terms of George W. Bush and <u>Donald Trump</u>, when there was little motivation to confront the global warming catastrophe, the US has consistently sent delegations of varying numbers to UN climate summits during the past three decades.

However. there will be an unprecedented lack of an official American presence at the forthcoming negotiations in Belém, Brazil, next month. Trump has already said that the US will leave the Paris Climate Accord, which requires nations to prevent the catastrophic rise in global temperatures, and referred to the climate catastrophe as a "hoax" and a "con job."

"The Green New Scam would have killed America if President Trump been elected had not implement his commonsense energy agenda - which is focused on utilizing the liquid gold under our feet to strengthen our grid stability and drive down costs for American families and businesses."

Taylor Rogers, a White House spokeswoman, said in a statement to the Guardian. The "scam" reference relates to the climate policies of Joe Biden.

"President Trump will not jeopardize our country's economic and national security to pursue vague climate goals that are killing other countries,"

she added.

The US State Department closed the office that usually handles climate problems earlier this year. Additionally eliminated is the role of climate envoy, which Biden held.

The White House has supported a strategy in which Trump makes deals directly with nations, abandoning multilateral negotiations with other nations.

Trump has also urged other countries to shift away from renewable energy.

"If you don't get away from this green scam, your country is going to fail," the president told leaders at a UN speech last month.

"You need strong borders and traditional energy sources if you are going to be great again."

The US president has negotiated deals in recent months with the European Union to buy \$750 billion worth of U.S. oil and gas, as well as with nations like South Korea and Japan to develop nuclear power. rare elements, and fossil fuel projects. An already problematic conference made is more complicated by the US's absence from the Belém negotiations.

With the message that subnational American authorities are still pushing forward with climate action, a variety of US governors, congressmen, mayors, and activists will be present at the Cop30 meeting.

However, the US government has

Bush-era nuclear moratorium: Trump's revival sparks cost concerns

hen Trump posted on Truth Social on Wednesday that he was ordering the "Department of War." his administration's name preferred for the Department of Defense. "immediately" begin testing America's nuclear stockpile "on an equal basis" to other nucleararmed nations, he seemed to overturn three-decade а live moratorium on nuclear explosions that had been in place since the last American weapons test in 1992.

Even a basic test that involves detonating a single warhead in an underground shaft might cost the <u>United States</u> upwards of \$100 million, according to one expert, former National Nuclear Security Administration acting principal deputy administrator Corey Hinderstein.

The action is purportedly intended to confront China's and Russia's advanced nuclear weapons delivery systems, as well as North Korea, which has been conducting illicit nuclear tests at underground facilities for years.

The United States last detonated a nuclear bomb there in 1992, deep beneath the Ranier Mesa.

Since 1962, when above-ground and underwater nuclear testing were outlawed by the Partial Nuclear Test Ban Treaty, the location has been the sole location for any American nuclear tests.

Resuming explosive testing at the

Nevada <u>site</u> might be a complex and expensive process, experts say, especially considering the experience lost since the last test more than thirty years ago.

interview with The In an Washington Post. Hinderstein. who leads the nuclear policy the program at Carnegie Endowment for International Peace, stated that a "new vertical shaft" would be required in order prevent interfering with existing projects at the test site.

Since the beginning of the second Trump administration, the NNSA has also experienced a loss of expertise.



For underground tests, deep perpendicular shafts must be drilled to contain the explosion and help radioactive release.

This structure requires complex engineering and environmental assessment. Tests must misbehave with transnational covenants proscribing atmospheric releases, so constraint technologies and covering systems must be strictly checked and streamlined.

Nuclear tests bear expansive safety, health, and environmental reviews, and must meet convention and domestic nonsupervisory scores.

Trump <u>announced</u> on the eve of Zelenskyy's arrival that he would meet Putin in Budapest, the capital of Hungary, on an unspecified date in an attempt to bring the war to a close.

The announcement of another Trump-Putin summit followed a phone call with the Russian president. "I believe great progress was made," Trump said on social media of the call.

Trump has already threatened to put crushing penalties on Russia's economy and set deadlines for Moscow, only to back down. After meeting or conversing with Putin, he has often loosened his position.

Although it would be symbolic to deliver Tomahawks the concept of which has already irritated the Kremlin they are only available in comparatively modest quantities, with some experts estimating that there are between 20 and 50 missiles.

In a startling reversal from the White House dressing-down in February that had exposed the breach between the two leaders, Trump and Zelenskyy spoke on the phone twice over the weekend in what the Ukrainian president called "productive" discussions.

"He [Zelenskyy] would like to have Tomahawks," Trump said on Tuesday. We have a lot of Tomahawks.

Ukraine lacks the ships and

submarines that are typically used to launch Tomahawks, which were first employed in war in 1991. With a range that puts Moscow well within reach and a significantly higher destructive potential than longrange drones, they are projected to cost \$1.3 million (£1 million) each.

Although launchers are few, there is also a more recent land-launched version, the Typhon, that is clearly more appropriate for Ukraine. Although the X-Mav, a launcher thought to be more mobile than the Typhon, was unveiled this week, the US army is only known to possess two. Rob Lee, a senior fellow at the Foreign Policy Research Institute, said:

"My understanding is that US doesn't have a lot of Tomahawks. There are launchers that can launch them from the ground, but the military doesn't have many of them."

Pavel Luzin, an independent Russian military analyst, said: "The Typhon system itself is new, still being produced for the US military. And it's not just a launcher – it includes transport and reloading vehicles as well as a dedicated command post."

The Trump administration has approved the sharing of US information in recent weeks to assist Ukraine in launching targeted strikes on Russian oil refineries with US-supplied Atacms missiles and

domestically built drones. Fuel shortages and a dramatic increase in gas prices have resulted from these attacks throughout Russia.

Although the cruise missiles are typically seen to be most effective when launched in salvos, which would be challenging with limited numbers, politicians and academics think the missiles may support that strategy.

What will Zelenskyy ask Trump regarding long-range missiles?

As he is about to meet with US President Donald Trump, Ukrainian President Volodymyr Zelenskyy is expected to make a very visible push for long-range Tomahawk cruise missiles.

The missiles have a maximum range of about 2,500 kilometers, which would allow Ukraine to reach and strike critical Russian military and strategic assets deep inside Russia, even near Moscow. Zelenskyy is seeing these missiles as an effective means of deterring and countering Russian aggressions more effectively by increasing the pressure on Russian military infrastructure.

Zelensky has indicated that they would not be using these missiles against anything other than Russian military targets, and that the proposed supply of Tomahawks would be significant enough of a supply to help bring an end to the war.

Volodymyr Zelensky open to joining Trump and Vladmir Putin talks



ollowing their phone conversation on Thursday, the presidents of the US and Russia declared that they will meet in Budapest to discuss the conflict in Ukraine, potentially within the next few weeks.

On Monday, Zelensky told reporters:

"If it is an invitation in a format where we meet as three or, as it's called, shuttle diplomacy... then in one format or another, we will agree".

According to media accounts, his Friday meeting with Trump at the White House turned into a"

crying match" in which the US side pushed Ukraine to agree to Russia's demands in order to stop the conflict.

Indeed though Zelensky was diplomatic during his first press conference since the accommodations, it was apparent from his reflections that there were significant points of contention between the two parties.

He claimed he had told Trump that his primary goal was just peace, not a speedy one, and <u>characterized</u> the encounter as candid.

According to him, Viktor Orban,

the prime minister of Hungary, who is viewed by Kyiv and many EU leaders as a friend of the Kremlin, is incapable of doing "anything positive for Ukrainians or even providing a balanced contribution" when it comes to the potential Trump-Putin meetings.

Trump stated that he wanted to "make it comfortable for everybody" when questioning reporters on Friday about Zelensky's participation in the meeting in Budapest.

Moscow said Monday that US Secretary of State Marco Rubio and Russian Foreign Minister Sergei Lavrov had a "constructive" phone conversation over the summit in Budapest.

During his visit to the White House, Zelensky had intended to get US Tomahawk missiles to launch attacks deep into Russia. According to media accounts, the Trump-Zelensky encounter had a much more heated mood than was previously thought.

According to sources involved with the discussion, the Financial Times claimed that Trump had threatened Zelensky that if he did not accept its terms, Putin would "destroy" Ukraine.

At the "volatile" meeting, the US side reportedly repeated Russian talking points. Additionally, it stated that Trump demanded Zelensky hand up the whole eastern Donbas region to Putin and threw out charts of the Ukrainian battle line.

Shortly after the meeting, Trump stated on social media that Russia and Ukraine "should stop where they are" that is, at the present, expansive front line.
"Let both claim Victory, let History decide!"
he said.

In response, Zelensky reiterated that Ukraine" will not gift anything to the raider" but stated that he was prepared for an immediate ceasefire.

Dmitry Peskov, Putin's prophet, stated Monday that Russia's station on the proposed freezing of the frontal line was" unchanged" but did n't give any other information.

In addition to a number of other harsh demands, Moscow has constantly called for the full departure of Ukrainian forces from the country's four southeast regions Donetsk, Luhansk(inclusively known as Donbas), Zaporizhzhia, and Kherson.

The demands, according to Kyiv and its allies, amount to a de facto rendition

Russia launched its full-scale

irruption of Ukraine in February 2022. It presently controls about 20% of Ukrainian homes, including the southern Crimea peninsula Moscow adjoined in 2014, as well as most- but not each- of the Donbas.

"We really didn't get what we wanted,"

Ukrainian political analyst Mykola Davyduik said of the latest Trump-Zelensky meeting

"A few days after, we received some insights from the meeting and some threats and pressure that the Ukrainian side received there,"
he told the BBC.

But he added:

"I don't think that Trump is fully and completely on Putin's side, and he is trying to play mediator... and that is his kind of style and how he behaves in such a situation."

In an effort to put more economic pressure on Moscow to halt the war, the US president has been urging China, India, and other NATO countries to cease buying Russian oil.

Additionally, although he never followed through on his threats, Obama had previously threatened Russia with harsher penalties if Putin failed to fulfill deadlines to advance the conclusion of the war.

After Trump and Vice-President

JD Vance criticized the Ukrainian president live on television during an Oval Office meeting in February, Trump's relationship with Zelensky had also significantly improved in recent months.

Trump asserted throughout his reelection campaign that he could put an end to the conflict in Ukraine in a matter of days.

What specific conditions has Ukraine set for joining a Trump-Putin summit?

Ukraine, under President Volodymyr Zelensky, has set specific conditions for joining an implicit Trump- Putin peak to discuss ending the war. First, Ukraine insists it must be formally invited to share in any concession involving its home and sovereignty.

Zelensky emphasized that any peace addresses must include Ukraine's direct involvement and consent to be legitimate. He expressed willingness to attend if invited to a format involving all three leaders or through shuttle diplomacy where Trump meets independently with both Putin and Zelensky.

Background on the fast-track citizenship initiative

Introduced as part of wider citizenship law reforms in 2024, the fast-track naturalisation option was designed to attract highly skilled immigrants by shortening the residency

requirement from five to three years for applicants who met rigorous criteria. These conditions included advanced Lisa Horizona language proficiency, detailed financial independence, and evidence of effective societal remove integration, as highlighted by citizent DW's reporting.

Despite these lofty goals, the programme saw limited uptake. Public broadcaster ARD reported immigration offices processed only a few hundred applications under this scheme, reflecting both limited awareness and possibly stringent eligibility criteria.

Impact and perspectives on repeal

Some critics voiced concern the abolition of the fast-track scheme could deter highly skilled labour needed Germany, a country facing labour shortages and an ageing population. However. 
Lisa Hoffmann of iamexpat.de detailed that the repeal came into effect on 30 October 2025. removing the three-year citizenship application option for new applicants from that date onwards. Future applicants must now comply with the standard five-year residency without exception. Fragomen, a global immigration consultancy, framed legislative change as a reflection of Germany's evolving political with environment. conservative-led Bundestag prioritising integration standards amid concerns about migration pressures.

Ongoing citizenship reforms

The government has maintained other reforms introduced by the previous Scholz administration, including easier access to dual nationality and a reduction in the residency requirement from to five vears naturalisation. The Guardian reports these measures as part of a complex migration strategy seeking to balance openness for integration-minded immigrants with stricter controls.

The SPD reiterated that while the fast-track was abolished, the overall citizenship process remains streamlined and aims to support effective integration and recognition of diverse migrant contributions to German society.

Italy PM Meloni urges Gaza aid flotilla to 'stop



Italian Prime Minister Giorgia Meloni has called on the

immediately cease its mission,

international Gaza aid flotilla to warning that breaching the Israeli naval blockade could

jeopardise the fragile balance necessary for peace. Meloni expressed concern about potential disruptions to the USbrokered peace plan, urging caution to prevent escalating tensions.

Italy's strong appeal to Gaza aid flotilla

As reported by Alvise Armellini of Reuters, on 30 September 2025, Italian Prime Minister urged Giorgia Meloni international flotilla seeking to deliver humanitarian aid to Gaza to halt its mission immediately. Meloni emphasised the risk that confronting Israel's naval blockade might undermine a delicate peace equilibrium, as laid out in the US peace proposal by President Donald Trump.In her statement, Meloni warned, "Many would be eager to disrupt" this fragile balance. She added, "I fear that the flotilla's attempt to breach the Israeli naval blockade could provide a pretext for escalating tensions. For this reason. I believe the Flotilla should stop now".

Political and diplomatic context

Arab News highlighted Meloni's insistence that a confrontation with Israel could unsettle the tenuous peace efforts underpinning the region's stability. She urged the flotilla organisers to reconsider their plans, reiterating that conflict escalation would be counterproductive and harmful. US News also covered Meloni's

remarks, citing her concerns drone thatany breach of the blockade could give detractors of the peace plan a justification to disrupt ongoing diplomatic efforts. Meloni's appeal came growing international attention on Gaza's humanitarian situation. juxtaposed with the complex geopolitical realities.

International reactions and flotilla dynamics

The Jerusalem Post reported that Italy had also warned the Global Sumud Flotilla that its naval frigate, which was shadowing the flotilla, would soon broadcast a radio message urging participants to abandon their mission and return to port. The flotilla consisted of over 40 boats carrying activists, lawyers, members of parliament, and notable climate advocate Greta Thunberg.

According to the BBC, Israeli officials previously stated that they intended to prevent any flotilla attempt to breach the blockade, having intercepted earlier efforts earlier in the year. Israeli Foreign Minister Gideon Saar supported the calls for the flotilla to halt, suggesting alternative delivery of aid via nearby ports.

Security incidents and flotilla escort

Al Jazeera and other outlets reported that the flotilla faced

drone attacks and communication disruptions near Crete, which Italy and Spain condemned as dangerous escalations. Italian naval vessels escorted the flotilla, highlighting the tense atmosphere surrounding the mission.

Reuters and EU News additionally noted that Italy's navy announced it would cease escorting the flotilla once it reached 150 nautical miles from Gaza's coast, signalling a cautious disengagement from the high-risk zone.

Public response and protests

Following the flotilla episode, large-scale protests and strikes erupted across Italy in support of the flotilla's humanitarian aims and to call for stronger actions against what demonstrators the called "genocide" in Gaza. Over two million Italians participated in a general strike organised by major labour unions. demonstrating solidarity with the Palestinian cause.
